

# NOTICE OF SCHOOL BOND ELECTION

## Cherry County School District #0030 Cody-Kilgore Unified Schools In the State of Nebraska

Public notice is hereby given to the qualified electors of Cherry County School District 0030 (Cody-Kilgore Unified Schools), in the State of Nebraska that a special election has been called and will be held on **July 9, 2024**, and the following proposition shall be submitted to the qualified electors of the District:

"Shall Cherry County School District 0030 (Cody-Kilgore Unified Schools), in the State of Nebraska, issue the bonds of said District in the principal amount of not to exceed Three Million Dollars (\$3,000,000) for the purpose of paying the costs of constructing additions and improvements to the existing high school building; said bonds to be issued from time to time as may be determined by the Board of Education, to bear interest at a rate or rates to be determined by the Board of Education and to become due at such time or times as may be fixed by the Board of Education; and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in said District sufficient in rate and amount to pay the interest and principal of said bonds as the same become due?"

FOR said bonds and tax

AGAINST said bonds and tax

Electors voting in favor of said proposition shall blacken completely the oval opposite the words "FOR said bonds and tax" following said proposition, and electors voting against said proposition shall blacken completely the oval opposite the words "AGAINST said bonds and tax" following said proposition.

Ballots will be mailed between June 18, 2024, and June 21, 2024, to all registered voters residing within the Cody-Kilgore Unified Schools District at his/her address as it appears on the voter registration register. Voted ballots, sealed in the Return Identification Envelope, may be returned by mail, in person, by agent, or deposited in the ballot drop box outside of the Cherry County Courthouse. All ballots must be in the possession of the Cherry County Election Commissioner no later than 5:00 PM CT on Election Day, July 9, 2024, regardless of postmark date.
