Emergency Management Director Jessica Coyle updated the board re: North Central 911 meetings did not have a quorum, and the next meeting is scheduled for Spring, will be attending the PET meeting on the 23rd of February, will be attending the Keya Paha meeting regarding dispatching for Keya Paha County. Keya Paha would like to combine the interlocal for the 911 dispatch and Emergency Management. Questions have been forwarded to John regarding the CWDG.

The Highway Superintendent job description was reviewed by the board. DeNaeyer moved and Nelson seconded to accept the Highway Superintendent job description and authorize the Chaiman to sign. Roll call vote: Aye –Nelson, DeNaeyer, McConaughey. The motion carried.

The Cherry County South Extension Office Bid was revised to include a wall not stated on the original bid. The board agreed to move the door down so as not to interfere with the exit door. Nelson moved to approve the bid for Cherry County South Building for \$20,706.46 as a revision of previous estimate approval from Dick Clark Construction. DeNaeyer seconded. Roll call vote: Aye — DeNaeyer, McConaughey, Nelson. The motion carried.

Audit draft approval from Contryman Associates was reviewed and McConaughey took the lead. Nothing was alarming and the auditors stated the county was doing a good job. ARPA funds will be reviewed but will not require a full single audit. Having no concerns, McConaughey moved to approve the 2023-2024 Audit Draft. DeNaeyer seconded the motion. Roll call vote: Aye—McConaughey, Nelson, DeNaeyer. The motion carried.

The Skid Steer purchased for District 2 has been delivered there are minor things that need to be done. The loan is from Security First Bank with 20% down and three annual payments. It was discussed that Road Department loans should have two commissioners signing loan documents. The district initiating the loan and the Chairperson should sign. If the loan is in the Chairperson's district the other two commissioners will need to sign the loan documents. DeNaeyer moved to authorize the loan for skid steer in District 2 from Security First Bank as presented and authorized the Chairman & Road District 2 Commissioner to sign. Roll call vote: Aye —Nelson, DeNaeyer, McConaughey. The motion carried.

DeNaeyer made a motion to accept Michael McLeod's resignation from the Planning & Zoning Board. McConaughey seconded. Roll call vote: Aye – DeNaeyer, McConaughey, Nelson. The motion carried.

McConaughey made a motion to re-appoint Gordon Witte and Wade Andrews to Planning & Zoning starting 2025 and ending 2028. Nelson seconded. Roll call: vote: Aye –McConaughey, Nelson, DeNaeyer. The motion carried.

DeNaeyer made a motion to appoint James Ward to replace Albert Ericksen on the Planning & Zoning Board. Motion died for lack of a second.

McConaughey made a motion to appoint Bill Wachob to replace John Lee with a one-year term. Nelson seconded. Roll call vote: Aye –Nelson, DeNaeyer, McConaughey. The motion carried.

Nelson made a motion to appoint Chad Tetherow to take the place of Michael McLeod for a two-year term. McConaughey seconded the motion. Roll call vote: Nay — DeNaeyer, Aye - McConaughey, Nelson. The motion carried.

Nelson made a motion to appoint Gary MacLeod to replace Albert Ericksen for a three-year term. McConaughey seconded the motion. Roll call: vote: Aye –McConaughey, Nelson, Nay – DeNaeyer. The motion carried.

Chad Thies, Zelle Human Resources Solutions, appeared via zoom. Concerns were raised regarding not having the budget, length of contract, cost of contract and possible internal resistance. Nelson asked about a focused project to work on Time Clock Plus and payroll issues. A quote could be available by the end of the week for the focused project. No action taken.

McConaughey made a motion to set a date and time for Conditional Use Permit - CUP#004/24 Sharp's Outfitters LLC, RV Electrical Hookups on Existing Campground on February 25, 2025 at 11:00 a.m. CT. DeNaeyer seconded and asked to have the Public Hearing properly advertised. : Aye—Nelson, DeNaeyer, McConaughey. The motion carried.

At 11:27 a.m. Chairman McConaughey adjourned the meeting.
