## BOARD OF COMMISSIONERS MINUTES October 28, 2025

The Cherry County Board of Commissioners convened in regular session on October 28, 2025 in the Commissioners Meeting Room of the Cherry County Courthouse, as per notice in the Valentine Midland News every week, with the agenda being on file in the office of the County Clerk. The meeting was called to order at 1:00 p.m. by Chairman McConaughey. Roll call was taken. Present for the meeting were Commissioners Mike McConaughey and Nina Nelson, and County Clerk Samantha Leonard. Commissioners Martin DeNaeyer had an excused absence for the beginning of the meeting. The Open Meetings Act Poster was acknowledged by Chairman McConaughey and the Pledge of Allegiance was recited.

At 1:10 p.m. Commissioner DeNaeyer was present for the remainder of the meeting.

The Board of Commissioners' regular meeting minutes from October 14, 2025 were read. McConaughey moved and Nelson seconded to approve minutes with noted corrections. Roll call vote: Aye – McConaughey, Nelson. Abstain – DeNaeyer. The motion carried.

The Board of Equalization meeting minutes from October 14, 2025 were read. Nelson moved and DeNaeyer seconded to approve minutes as read. Roll call vote: Aye – Nelson, McConaughey, DeNaeyer. The motion carried.

The Board of Corrections meeting minutes from October 14, 2025 were read. McConaughey moved and Nelson seconded to approve minutes as read. Roll call vote: Aye – McConaughey, DeNaeyer, Nelson. The motion carried.

Comments from the public were received during the allotted time.

The board discussed abandoning part of 908<sup>th</sup> Road with Road Foreman JD Osburn. Mr. Osburn stated to start the process of abandonment, the board must authorize him to do a commission report, present the report to the board, and hold a public hearing. If the road is abandoned, the property line will move to the center of the road, and the land will go back to the adjacent landowners. The county will no longer be responsible to maintain the road after abandonment. If abandoned, the bridge will be sold to the highest bidder, and the county removes the weight restriction signs from the bridge. Nelson moved and McConaughey seconded to authorize JD Osburn to produce a commission report to abandon a portion of 908<sup>th</sup> Road. Roll call vote: Aye – DeNaeyer, Nelson, McConaughey. The motion carried.

The board recessed to convene as a Board of Corrections from 1:30 p.m. to 1:37 p.m.

At 1:37 p.m. the board met with Agricultural Society members Duane Witte and Jon Kime to discuss documentation submitted with a grant claim. Mr. Witte stated there was only one signature on the deposit & withdrawal form because of the lack of room on the electronic pad at the bank for two signatures, but the withdrawal was a transfer from one account to another. It was a consensus of the board to include Claim #25107199 to be paid with November 12, 2025 claims.

Grounds Superintendent Pat Greenough met with the board and presented bids for the Courthouse door from Lower Construction with labor included in the written bid. Mr. Greenough also presented bids from Stec Electric LLC and Anderson Electric to replace the outdoor lights of the Courthouse. The parts from the old lights will be kept as replacements for the remaining lights on the courthouse property. McConaughey moved and DeNaeyer seconded to accept Anderson Electric bid for \$3,542.00 to remove and dispose of 11 outdoor lights and replace existing fixtures with new adjustable LED wall packs, to be paid for by the Special Building Fund. Roll call vote: Aye — Nelson, McConaughey, DeNaeyer. The motion carried. DeNaeyer moved and Nelson seconded to accept Lower Construction's bid for \$3,432.75 to replace the south door on the Cherry County South building to be paid for by the Special Building Fund. Roll call vote: Aye — McConaughey, DeNaeyer, Nelson. The motion carried.

The board discussed surplus equipment and vehicles with the road foremen. McConaughey moved and DeNaeyer seconded to surplus the list of equipment and vehicles as presented to be listed on Purple Wave. Roll call vote: Aye – DeNaeyer, Nelson, McConaughey. The motion carried.

At 2:00 p.m. NIRMA Attorney Jeff Kirkpatrick met with the board via phone for a legal update re: BSH Kilgore LLC vs. Cherry County, et al Case #CI25-42. Mr. Kirkpatrick informed the board he filed a motion to dismiss based on the unclear answer if the Board of Adjustments has jurisdiction to hear the appeal filed by BSH Kilgore. The motion to dismiss will be heard in Cherry County District Court on December 19, 2025 at 11:30 a.m. via zoom. A brief of the bearing will be sent to the board in December.

The board discussed the Zoning Administrator payroll reimbursement for September 2025. Commissioner McConaughey stated he discussed this matter with Contryman Associates Auditor Jada Thompson, and she had no concern for her auditing duties. McConaughey moved and Nelson seconded to reimburse the current Zoning Administrator Jane Stolzenburg \$837.50 for September 2025 payroll. Roll call vote: Aye — Nelson, McConaughey, DeNaeyer. The motion carried.

Zoning Administrator Jane Stolzenburg submitted a letter of resignation to the board. DeNaeyer moved and McConaughey seconded to accept Ms. Stolzenburg's resignation. Roll call vote: Aye – McConaughey, DeNaeyer, Nelson. The motion carried.

McConaughey moved and Nelson seconded to advertise for the Cherry County Zoning Administrator position. Roll call vote: Aye – DeNaeyer, Nelson, McConaughey. The motion carried.

The board reviewed the MOU to renew for an additional two years for "VetraSpec" benefits for the Veterans Service Office. DeNaeyer moved and Nelson seconded to enter the MOU for "VetraSpec" as presented and authorize the chairman to sign. Roll call vote: Aye – Nelson, McConaughey, DeNaeyer. The motion carried.

The board discussed the Merriman Siren invoice from Federal Signal Corporation. Emergency Management Director Jessica Coyle informed the board the siren is scheduled to be installed next week, and it was a consensus of the board to submit the invoice to be paid with November 12, 2025 claims. No board action taken.

The board discussed Aflac Dental Options as presented. Nelson moved and McConaughey seconded to accept the Brochure Option 4 Aflac Dental Plan as presented by Dan Riha, effective January 1, 2026. Roll call vote: Aye – McConaughey, DeNaeyer, Nelson. The motion carried.

The board reviewed the Certification of Distress Warrants issued to the Sheriff as presented by Treasurer Kathy Hammond.

Elected Officials and Department Supervisors met with the board to discuss the current handbook. Discussion was had re: PTO/Sick leave benefits, use of county owned vehicles, introductory period, documentation of employees' hours worked, moonlighting, health insurance, and meal breaks. Clerk Leonard will continue to work with elected officials to update the handbook to present to the board. No board action taken.

At 4:07 p.m. DeNaeyer moved and McConaughey seconded to enter executive session by the request of an employee to discuss personal matters with the board, employee, and Clerk to be present. Roll call vote: Aye — DeNaeyer, Nelson, McConaughey. The motion carried.

At 4:44 p.m. the meeting room doors were opened, and the public was allowed to reenter. DeNaeyer moved and McConaughey seconded to exit executive session. Roll call vote: Aye – Nelson, McConaughey, DeNaeyer. The motion carried. Commissioner McConaughey restated the reason for executive session.

McConaughey moved and DeNaeyer seconded to approve claims as presented. Roll call vote: Aye – McConaughey, DeNaeyer, Nelson. The motion carried.
