

**Resolution #2026-01**  
**Abandonment of 908<sup>th</sup> Road**

**WHEREAS**, the County Board of Cherry County, Nebraska, has deemed it in the public interest of the citizens of Cherry County, Nebraska, that the road described as allows to wit:

That part of County Road 908<sup>th</sup> Road, formerly road No.9, lying between Sections twenty-four (24) and twenty-five (25), Township Thirty-five (35) North, Range Twenty-nine (29), West of the 6<sup>th</sup> P.M. in Cherry County, Nebraska.

**WHEREAS**, the County Highway Superintendent has submitted his report, in writing, as provided by Section 39-1722, Neb. Rev. Stat. 1943 (R.R.S. 2025), which report is a study of the use of said road; and

**WHEREAS**, pursuant to Section 39-1724, Nebraska Revised Statutes (2025), requires, upon receipt of a report on said road from the County Highway Superintendent that a public hearing on the question of whether or not said road should be abandoned or vacated,

**NOW THEREFORE BE IT RESOLVED** by the County Board of Cherry County, Nebraska, that a public hearing pursuant to Section 39-1724, Nebraska Revised Statutes (2025), be held to consider the abandonment or vacation of said road.

**BE IT FURTHER RESOLVED** that said public hearing shall be held on the 10<sup>th</sup> day of February 2026, at the hour of 11:00 o'clock a.m. in the Commissioners meeting room at the Cherry County Courthouse in Valentine, Nebraska.

**BE IT FURTHER RESOLVED** that this Resolution shall be published once a week for three (3) consecutive weeks in the Valentine newspaper at Valentine, Nebraska.

**BE IT FURTHER RESOLVED** that copies of this Resolution be provided by either registered or certified mail to all of the owners of land abutting on or adjacent to the road to be abandoned or vacated, said notice to be provided not less than two (2) weeks prior to the hearing date established herein.
